There are no water hookups or electricity hookups available.** The hours of operation we require are 5:00 pm to 7:00 pm on Fri, June 30th, July 1st through July 3rd, 12:00 pm through 7:00 pm, and Tuesday July 4th 11:00 am through 7:00 pm. Hours beyond that, is at your discretion. The fee is \$240.00.

Contractor shall be required to indemnify, defend, and hold harmless the Sedro-Woolley Chamber of Commerce and the City only to the extent claim is caused in whole or part by negligent or intentional acts or omissions of the City. I have all permits, licenses, insurance, etc. required by the city, county, and state to operate a legal business. I am of legal age (18 years or older).
