The hours of operation we require are July 1st thru July 3rd from 1:00 to 7:00, except on the 4th from 11:00 am to 7:00 pm. Hours before or beyond are at your discretion. You are allotted a 10 ft x 10 ft space. The fee is \$100.00 This fee is non-refundable.

Contractors shall be required to indemnify, defend, and hold harmless the Sedro-Woolley Chamber of Commerce and the City only to the extent claim is caused in whole or in part by negligent or intentional acts or omissions of the City. I have all permits, licenses, insurance, etc. required by the city, county, and state to operate a legal business. I am of legal age (18 years or more).
