EVENT GUIDELINES *

CHECK-IN/SETUP.

Depending on your vendor space assignment, your Wednesday setup times can take place between 8 AM – 1 PM Overnight security will be provided Wednesday, Thursday and Friday. Check in with a Loggerodeo staff member at the park or call 360-853-3040. You are responsible for managing your own setup. Your setup must be complete and ready for festival goers prior to 1 PM Wednesday. If you need more time, you can request that from us by email or calling, and we will try to ask the city for the day before.

BOOTH SIZE AND ASSIGNMENTS.

Booth spaces will be pre-assigned. Your booth space is measured in Width x Length (Length (INCLUDING ANY OVERHANGS /AND TONGUE) + frontage selling space (including storage containers, displays, etc.)). Your operation must fit inside your booth space in its entirety. This includes trailer tongues, door openings, storage containers, displays, etc. "Pop up" style tents must be in good condition; no tarps or makeshift tents are allowed.

HOURS OF OPERATION REQUIRED.

Your operation must be staffed and operational throughout festival hours. You may be open later for the Carnival may be open later depending on weather/crowd.

Wednesday July 1st, 2026, 1:00 pm to 8:00 pm

Thursday July 2nd, 2026, 1:00 pm to 8:00 pm

Friday July 3rd, 2026, 1:00 pm to 8:00 pm

Saturday July 4th, 2026, 11:00 am to 8:00 pm

CLEANLINESS.

Your booth space must be kept tidy throughout the festival. You are responsible for performing cleanup throughout the festival of your booth space and any debris originating from your operation. You must provide trash receptacles and liners for your mobile operation. At all times your vendor space needs to comply with Skagit County Health Department code. All food handler's rules and regulations need to always be followed.

TEARDOWN.

Saturday at 8 PM is the earliest your teardown can begin. There are festivities after teardown the carnival is going till around 11 pm and the fireworks are at 10 pm on Saturday. For your information the roads out of the park may be closed at 8 pm to approx. 10:30 pm for the fireworks to increase the safety of the community.

SECURITY, LOSS AND CLAIMS.

Loggerodeo, The City of Sedro-Woolley are not liable for lost, stolen or damaged items. Furthermore, neither Loggerodeo, nor the City, maintains insurance that will respond to claims made against you or your operations arising out of your participation. You must have insurance listing the Loggerodeo Inc. as an additional covered and provide a copy to the Loggerodeo.

SUBSTITUTIONS OF MENU.

Substitutions for the sale of food or services you have outlined in your application require prior written consent from Loggerodeo.

STANDARD OF BEHAVIOR.

Vendors are expected to behave in a respectful manner while taking part in the festival. Loggerodeo reserves the right to close a vendor's operation if the vendor exhibits inappropriate behavior or disregards the guidelines set forth herein. There will be a ban on your participation at the discretion of the Loggerodeo's board up to 3 years.

Attendance.

The festival's attendance and your sales volume cannot be guaranteed.

No Refunds.

Once paid, your Booth Fee is a non-refundable for any reason. The event will take place in rain or shine. A refund will be provided ONLY if the event is canceled by its Organizers when it has been deemed a threat to public safety.

No Electricity or Water.

There are no Electric hookups available, generator can be used but is not provided. Water is not provided or available.

Inspections.

Your vendor operation is subject to inspection by the City of Sedro-Woolley Fire Marshal and the Skagit County Health Department

SPACE USAGE

Your vendor space is to only be used for selling items approved by the Loggerodeo, there is to be NO camping overnight at the Carnival, Park, Baseball Park, Field Parking or Vendor sites. Please inquire at the campground to reserve a spot if camping overnight is needed. 360-855-1661
