CHECK-IN

- Location for check in is at Parade Central at the SWHS tennis courts on Jamison st.
- They will have your name and wrist bands for identification during the parade.

VENDING

- You will be Vending on the move.
- Best thing is having a wagon or cart.

SECURITY, LOSS AND CLAIMS

- Loggerodeo and the City of Sedro-Woolley are not liable for lost, stolen, or damaged items.
- You must carry your own insurance and provide a certificate naming Loggerodeo, Inc. as an additional insured.
- **No insurance** is provided by the organizers.

SUBSTITUTIONS OF ITEMS.

- Any changes to the items or services listed in your application require **prior written approval** from Loggerodeo.

STANDARD OF BEHAVIOR.

- Vendors must behave respectfully.
- **Loggerodeo reserves the right to close non-compliant booths** immediately.
- Violations may result in **fee forfeiture** and a **ban of up to 3 years**.
